

Vehicles

JAXPORT Cruise Terminal

- 63,000 square foot temporary terminal
- Constructed in 2003
- 78 Cruises per fiscal year
- 703,367 passengers over the past 3 years



Dames Point Marine Terminal

- Dames Point site = 585 acres
- Current "Bulk" cargo operations: limestone & granite
- Future use: MOL container facility



Talleyrand Marine Terminal

Facilities

- ▶ 174 Acres
- ▶ 6 Container cranes (up to 50 LT)
- ▶ 4,800 ft of Berthing Area
- On-Dock Access to 3 Railroads

Cargoes & Tenants

- Containerized
- Breakbulk (lumber, frozen chicken)
- Vehicles
- Liquid bulk



Blount Island Marine Terminal

Cargoes & Tenants

- Containerized cargo
- Vehicles & Heavy Equipment
- Breakbulk
- Liquid Bulk

Facilities

- 754 Acres
- 7,000 linear feet of wharf
- 8 Container Cranes
- 290,000-sq. ft. warehousing
- On-Dock Rail



The Container Cranes

- 14 Container Cranes at Two Terminals
 - 4 50-LT Capacity
 Cranes, \$6 million
 each

 Up to 40 containers can be moved per hour
